

The Government of Tamil Nadu has issued very strict instructions regarding Ragging. Any student found or reported to have indulged in or encouraged ragging will be dismissed from the College and legal steps will be taken as per the Tamil Nadu Government Gazette Extraordinary, Act NO. 7 of 1997 (Copy enclosed). The ragging incident will also be reported to the University and Director of Technical Education for further action. Further, the transfer Certificate Issued by the Institution will have a specific entry apart from that of general conduct and behavior whether a student has participated in and in particular been punished for ragging", as per the directive of the Honorable Supreme Court vide order dated 4/5/2001.

In addition to the above, as per the orders of the Honorable Supreme Court of India, "if any incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain and if his explanation is not found satisfactory, the authority would expel him from the institution".

Therefore, the students are hereby instructed not to indulge in ragging in any form either inside or outside the Campus. The parents are requested to advise their ward accordingly. The co-operation of all the parents and compliance from students is solicited in this matter.




Report on Anti-Ragging Rally



MINUTES OF THE MEETING (ANTI – RAGGING CELL)

The anti-ragging cell meeting was convened on 01.10.2021 at 11.00 A.M in the mini auditorium, A Block.

1. The chairman greeted all the members of the meeting and the key issues were highlighted.
2. The cell resolved the minutes of the previous meeting.
3. The cell appreciated all the members and squad for maintaining no registered complaints against ragging in the campus.
4. The cell congratulated all the members for the successful completion of Anti ragging rally in the campus.
5. It was decided that the constituted anti ragging cell and squad will continue its function until further notice.
6. The Cell members reported the following measures that are taken to sensitize students to Zero Tolerance Policy against ragging in the institution.
 - At the beginning of the academic year, the anti-ragging circular was circulated to all the students specifying the consequences of the ragging.
 - All the students were informed to fill and submit an affidavit stating that they will not participate in any activity related to ragging on campus. It is signed by the student, parent, signed and sealed by a NGO at their residential area and submitted to college office.
 - Anti ragging rally conducted every year to create awareness to curb the menace of the anti-ragging in the campus.
 - Information regarding the members of the anti- raging cell is displayed on notice boards for the ease of the students.
 - The active mentoring process in the college enables all the students to meet their mentors regarding ragging related issues.
 - The college Counsellor is available on campus to all students in full time. The students can meet the counsellor for any ragging related issues.

- A separate Lunch time is maintained for junior and senior students in the college to forbid ragging.
 - The faculty incharge for all the buses are appointed to sustain ragging free buses.
 - All the junior class rooms are organized near to the faculty room to prohibit ragging in the campus.
 - All the junior students are allotted rooms in the ground floor of the hostel to prevent ragging in the Hostel.
7. The schedule of the next meeting was confirmed in the Month of October 2022, or earlier if needed.
